Drug Testing Participation and Consent Form and Waiver/Release of Liability

NOTE: THIS DOCUMENT IS IN TWO PARTS. BOTH PARTS MUST BE REVIEWED CAREFULLY, SIGNED BY THE APPROPRIATE INDIVIDUAL, AND RETURNED TO THE BUILDING ACTIVITIES DIRECTOR BEFORE A STUDENT MAY PARTICIPATE IN ANY ACTIVITIES/ATHLETICS.

The term "Activities/Athletics" applies to all MSHSAA-sanctioned activities listed in the District's Drug Testing Program.

PART ONE: STUDENT

I am voluntarily choosing to participate in Activities/Athletics, and thus agree as follows:

1. I have read and understand the Moberly Public School District Student Activity/Athletic Handbook. I agree that participation in school-sponsored Activities/Athletics is a privilege and not a right. I am aware of the District's requirements for participation in school-sponsored Activities/Athletics and agree to abide by the requirements and consequences as outlined in the handbook. I am also aware that individual coaches/sponsors may impose additional requirements and rules for participation and that they may establish additional consequences for conduct that violates specific team rules.
2. I will be a participant in, and fully and knowingly consent to participation in, the Moberly Public School District's Drug Testing Program for Students Involved in MSHSAA-Sanctioned Extra-Curricular Activities ("Testing Program"). I have carefully read and understand the terms of the District's policy that explains the Testing Program, and thus, I agree to comply with and abide by the terms of that policy.
3. I understand that my signature below authorizes the District to obtain a urine sample from me in accordance with the Testing Program. I further understand and agree that the District may respond to a positive drug test result in accordance with the provisions of the Testing Program. My consent will remain in effect unless I have provided written notice of revocation to the Principal.
4. By signing this form, I hereby waive and release the District – the term "District" defined as including the District as an entity and its employees, Board, members, agents, representatives and volunteers, in their respective official and individual capacities – from all claims, demands, and/or liability for any injury, harm, loss and/or damage arising in any manner from my participation in Activities/Athletics. I agree to hold the District harmless against all claims and/or other demands arising as a result of my participation in Activities/Athletics. I will not bring any legal action or assert any claims of any kind against the District (as defined above) for any injury, harm, loss, or damage arising out of my participation in Activities/Athletics. I sign this waiver and release voluntarily and with a full and complete understanding of its contents.

By signing this form, I, on behalf of myself and my child, hereby waive and release the District – the term "District" being defined as including the District as an entity and its employees, Board, members, agents, representatives and volunteers, in their respective official and individual capacities – from all claims, demands, and/or liability for any injury, harm, loss and/or damage arising in any manner from my child's participation in Activities/Athletics. In addition, I agree to hold the District harmless against all claims and/or other demands arising as a result of my child's participation in Activities/Athletics. I further understand that because I am signing as the parent/legal guardian of a minor-aged participant, I am specifically waiving and releasing all of the rights that the minor-aged participant might otherwise have had. I will not bring any legal action or assert any claims of any kind against the District (as defined above) for any injury, harm, loss, or damage arising out of my child's participation in Activities/Athletics.
